ORDER:

In the reference 1st read above, the Government have issued the Andhra Pradesh Building Rules, 2017 applicable to the building activities in the State, based on the Model Building Bye-Laws, 2016 of Government of India. Subsequently, the Govt., vide reference 2nd to 7th cited have issued amendments to the AP Building Rules, 2017, in order to make the building environment safe, inclusive, environmentally sustainable and contribute towards economic development and enhance Ease of Doing Business (EoDB) and to have investment friendly environment in the State.

2. The Director of Town & Country Planning vide reference 8th cited has submitted that there is a need to amend the Building Rules in respect of Industrial Buildings and liberalizing the Building Regulations for Standalone Factories and Flatted Factories to incentivize setting up of multi-storied units with high work density close to city centres.

3. Government after careful examination of the matter and in order to incentivize setting up of multi-storied units with high work density close to city centres as part of liberalizing the Building Regulations for Standalone Factories and Flatted Factories, hereby issue the following amendments to the AP Building Rules, 2017 issued vide reference 1st read above read with subsequent amendments issued vide reference 2nd to 7th read above.

NOTIFICATION

In exercise of the powers conferred by section 585 read with section 592 of the Andhra Pradesh Municipal Corporation Act, 1955 (adapted GHMC Act, 1955); section 18 of the Andhra Pradesh Municipal Corporations Act, 1994; section 326 of the Andhra Pradesh Municipalities Act, 1965, section 44 (1) of the Andhra Pradesh Town Planning Act, 1920, sub-section (2) of section 18 of the Andhra Pradesh Capital Region Development Authority Act, 2014 and Sections 116 & 117 of the Andhra Pradesh Metropolitan Region and Urban Development Authorities Act, 2016, the Government of Andhra Pradesh hereby makes the following amendments to the AP Building Rules, 2017 issued in G.O.Ms.No.119, MA&UD (H) Dept., dated 28.03.2017 and amendments issued thereon from time to time.

AMENDMENTS

In the said Rules:-

I. In Rule 2,-

1. **in sub-rule (103), the following clause (a) shall be added, namely,-**

"103(a) Flatted Industry

FLATTED INDUSTRIES' means a multi-storied industrial building subdivided into small, separately occupied units, which are used for manufacturing, assembly, and storage purposes:

II. In Rule 3,-

1. **in sub-rule (10), in clause (xxiii) after the sub-clause (6) the following shall be added, namely,-**

In case of heavy industries irrespective of height, Structural designs and drawings prepared duly taking the soil bearing capacity into consideration and certified by IIT, NIT, JNTU, Andhra / Venkateswara or any other government university is mandatory

III. In Rule 57,-

1. **in sub-rule (2), for clause (a) the following table 17(a) shall be added, namely,-**
